ICC Elementary School Rules and Regulations

- 1. **Islamic Environment and Behavior:** All Islamic laws and regulations must be followed in all aspects of life including prayers, dress, social interactions, etiquettes, manners and morals and will be expected and enforced.
- 2. Class Attendance: All classes must be attended except when excused by a teacher or principal. If, in any event, a student is needed to be sent home, the parents or guardians must, without objection or delay, make necessary arrangements for the student's return home.
- 3. Arrival and Pick-up Policy: Parents are fully responsible to bring their child on time (8:25am) and pick up at 3:25pm. ICC is not responsible for student custody after hours. Multiple and extraneous late pick-ups will result in a late pick-up fine.
- 4. **Internet and Technology Usage:** Students are allowed to use technology such as computers and internet and must follow instructions accordingly to maintain these privileges. ICC maintains a STRICT NO TOLLERANCE POLICY where inappropriate conduct, material that is offensive or dangerous that is accessed will count for immediate suspension of internet and computer privileges, possibly affecting the completion of the program requirements and participation of activities.
- 5. Off Premise Behavior: Students are expected to adhere to Islamic behavior and reflect the morals and good behavior of Muslims when leaving school premises including outdoor park activities and field trips. Inappropriate behavior and actions will result in the student's removal of outdoor activities, removal of permission to attend field trips and possible expulsion from the program.
- 6. Dress Code: All students must wear appropriate clothing according to Islamic guidelines as outlined in the Student Policy Handbook Dress Code Policy.
- 7. Cell Phones/Electronic Devices: Cell phones and any other electronic devices such as tablets, or computers are not allowed at any time during school hours. The office phone is available as the main way for students and parents to communicate to each other at any time. Cell phones and devices that are found being used or on students person will be confiscated and then given back to parents at pick up time at the end of the day.
- 8. General Behavior: While students are expected to adhere to Islamic standards, ICC Elementary School has a NO TOLERANCE Policy towards any type of bullying towards other students or staff including verbal, physical or the misuse of property of others and that of ICC. Discipline actions will result with a first time offense with a behavior note home and a secondary offense with suspension from the program and any further offenses expulsion from the program. Each offense will be handled accordingly on a case by case basis and level of severity.
- 9. All above mentioned rules as well as those outlined in the Student Policy Handbook (at iccelementaryschool.com) and future rules will be followed.
